### 1.0 PREFACE

## Mr. Speaker Sir,

On behalf of the Committee on Land, Housing, Physical Planning and Urban Development and pursuant to Standing Order 191 (5)(f), it is my duty and pleasure to present to the House the committee's report on vetting and consideration of nominees for appointment to Dadaab municipality Board.

This is one of the Sectoral Committees established under the Standing Orders 191(1). Among its functions are to vet and report on all appointments where the constitution or any law requires the County Assembly to approve, except those under Standing Order 185(Committee Appointments).

#### Mr. speaker sir,

The legislative authority of a county is vested in, and exercised by its county assembly as provided for in article 185 of the constitution of Kenya, 2010. A county assembly may make any laws that are necessary for incidental to the effective performance of the function and exercise of the powers of the county government under the fourth schedule.

### 1.1 Mandate of the Committee

#### Mr. Speaker Sir,

The Departmental Committee on Lands, Housing, Physical Planning and Urban Development is one of the Departmental Committees of the County Assembly of Garissa established under *Standing Order 191(1)* whose mandate, pursuant to the *Standing Order 191 (5)* is to, among others;

- i. Investigate, inquire into and report on all matters relating to the mandate, management, activities, administration, operation and estimates of the assigned department;
- ii. Study programs and policy objectives of departments and the effectiveness of the implementation;
- iii. Study and review all county legislation referred to it;
- iv. Study, assess and analyse the relative success of departments as measured by the results

obtained as compared with their stated objectives;

- v. Investigate and inquire into all matters relating to the assigned departments as they may deem necessary, and as may be referred to them by the County Assembly;
- vi. To vet and report on all appointments where the constitution or any law requires the County Assembly to approve, except those under Standing Order 185 (Committee Appointments); and
- vii. Make reports and recommendations to the county assembly as often as possible, including recommendation of proposed legislation.

In accordance with the Second Schedule of the Standing Orders, the Committee is mandated to consider matters of county housing, street lighting, traffic and parking etc.

Further, members of the public were expected to participate in the vetting process by submitting written statements on oath on the suitability or otherwise of the nominees before 14<sup>th</sup> July, 2023. As at close of business on 13<sup>th</sup> July, 2023 no memoranda had been submitted.

#### 3.3 CLEARANCE REQUIREMENT

On 7<sup>th</sup> July, 2023, the Clerk of the County Assembly wrote letters to the Ethics and Anti-Corruption Commission, the Kenya Revenue Authority (KRA) and the Higher Education Loans Board (HELB), respectively, requesting for information on whether the nominees have any active or ongoing investigations against them, are tax compliant and whether they owed any loans to the loans Board. This was purposely done to seek information on the integrity of the nominees. The nominees were also required to present their Certificates of Good Conduct.

#### 3.4 SUBMISSION OF RELEVANT DOCUMENTS FROM THE NOMINEES

The committee received the following documents from the nominees.

- 1. Curriculum vitae, personal credentials and academics certificates.
- 2. identity card.
- 3. Compliance certificate from KRA.
- 4. Clearance certificate from EACC.
- 5. Clearance certificate from HELB.
- 6. Police clearance certificate from CID department.
- 7. Clearance certificate from credit reference bureau (CRB)

#### 4.0 COMMITTEE MEETINGS.

The committee held two sittings prior to approval hearing to familiarize themselves with the public appointments (county assembly approval) Act No 5 of 2017, curriculum vitae of the nominees, consider memoranda received thereof and other preparations relevant to the task at hand.

## 5.0 Establishment of the Board of the Municipality Hon Speaker Sir,

Clause 3 of the Dadaab Charter establishes Dadaab Municipality Board with the following functions;

- (a) Oversee the affairs of the Municipality.
- (b) Develop or adopt policies, plans, strategies and programmes and set targets for service delivery.
- (c) Formulate and implement an integrated development plan.
- (d) Promoting and undertaking infrastructural development and services within Municipality as delegated by the County Government of Garissa
- (e) Developing and managing schemes, including site development in collaboration with the relevant national and county agencies.
- (f) Maintaining a comprehensive database and information system of the administration.
- (g) Administering and regulating its internal affairs.
- (h) Implementing applicable national and county legislation.
- (i) Entering into contracts, partnerships or joint ventures as it may consider necessary for the discharge of its functions.
- (j) Preparing of its annual budget estimates and submitting the same to the County Treasury for consideration and submission to the County Assembly for approval as part of the annual County Appropriation Bill.
- (k) Collecting rates, taxes levies, duties, fees and surcharges on fees as delegated by the County Government of Garissa.
- (l) Settling and implementing tariff, rates and tax and debt collection policies as delegated by the County Government of Garissa.

- (m) Monitoring the impact and effectiveness of any services, policies, programs or plans.
- (n) Establishing, implementing and monitoring performance management systems.
- (o) Promoting a safe and healthy environment.
- (p) Facilitating and regulating public transport.
- (q) Performing such other functions as delegated by the County Government of Garissa.

## 6.0 CRITERIA FOR VETTING

The committee was guided by chapter six and article 195, 196 (1) and (2) of the constitution of Kenya 2010, the Urban Areas and Cities Act, No. 13, 2011, the Urban Areas and Cities (Amendment) Act 2019 and section 7,8,9,10, first and second schedules to the public appointments (county Assemblies Approval) Act.

#### 7.0 COMPOSITION OF THE MUNICIPALITY BOARD

On composition of the municipality board, section 14 of the Urban Areas and Cities (Amendments) Act, 2019 stipulates that; -

- 1. A Board of municipality shall consist of nine (9) members appointed by the county governor with the approval of the county assembly.
- 2. The members of the board appointed under subsection (1) shall be constituted as follows
  - a) The county executive member for the time being responsible cities and urban areas or his representative;
  - b) Three members who shall be appointed by the county governor with the approval of the county assembly;
  - c) Four members who shall be nominated by an association and appointed by the county governor, with approval of the county assembly;
  - d) The chief officer responsible for urban development; and
  - e) The municipal manager appointed under section 28 of the Urban Areas and Cities Act 2011, who shall be the secretary of the board and an ex- officio member of the board.
- 3. The four members of the board of the municipality specified under subsection (2) (c), shall be nominated by
  - a) An umbrella body representing professional associations in the area

- b) An association representing the private sector in the area;
- c) A cluster representing registered associations of the informal sector in the area; and
- d) A cluster representing registered neighbourhood associations in the area

- 4. The county governor shall, while appointing the members of the board, ensure gender equity, representation of person with disability, youth and marginalized group.
- 5. The county governor shall while considering the nominated members, identified by the organizations specified under subsection (2), require the organization to produce
  - a) Signed minutes as evidence of an accountable process of the nominations.
  - b) Evidence of compliance with statutory obligations; and
  - c) Vetting to establish that the nominee has complied with the prescribed criteria for appointment as a member of the board.
- 6. A person shall be qualified for appointment as a chairperson of the board if that person
  - a) Holds at least a degree from an institution recognized in Kenya;
  - b) Has a distinguished career in a medium level management position in either the private or public sector;
  - c) Holds at least ten years post qualification professional experience;
  - d) Satisfies the requirement of chapter six of the constitution;
  - e) Is ordinarily resident or has a permanent dwelling in the municipality and
  - f) Carries on business in the municipality or has lived in municipality for at least five years.
- 7. A person shall be qualified for appointment as a member of the board if that person
  - a) Holds at least a diploma from an institution recognized in Kenya;
  - b) Has a distinguished career in a medium level management position either the private or public sector;
  - c) Holds at least five years' post qualification professional experience and;
  - d) Satisfies the requirement of chapter six of the constitution;
  - e) Is ordinarily resident or has a permanent dwelling in the municipality;
  - f) Carries on business in the municipality or has lived in the municipality for at least five years.

#### 8.0 CRITERIA FOR ASSESMENT

The assessment of the Nominees was guided by section 14 of the Urban Areas and Cities Amendment Act 2019 and section 7, 8,10,12 and the assessment form set out in the second schedule of the public appointments (county Assemblies) Approval Act 2017

#### 9.0 VETTING OF NOMINEES

## Speaker Sir,

In conducting the vetting process, the Committee examined the nominees against the following criteria, amongst others, in accordance with the Public Appointments (County Assemblies) Approval Act and Article 73(2) (a) (b) (c) (d) and (e) of the Constitution and other applicable laws:

- i) Academic qualifications;
- ii) Employment records;
- iii) professional affiliations;
- iv) potential conflict of interest;
- v) knowledge of the relevant subject matter;
- vi) overall suitability for the position;
- vii) tax compliance;
- viii) Integrity.

The Committee therefore complied with the Constitutional and legal requirements on vetting. As stated earlier, it ensured public participation and openness in the vetting process.

## 9.1 Approval Hearing

## Mr. Speaker Sir,

The Committee conducted an approval hearing for the nominees on appointment to Dadaab Board on Friday, 14<sup>th</sup> July, 2023. In conducting the vetting exercise, the Committee was guided by, among other documents, the Constitution of Kenya 2010, Urban Areas and Cities Act 2011 & 2019 (Amended), the Public Appointments (County Assemblies Approval) Act (No. 5 of 2017) and the Standing Orders. In coming up with observations and recommendations for appointment of the nominees, the Committee examined the nominees using the guidelines provided for in the Public Appointments (County Assemblies Approval) Act No. 5 of 2017.

- Implementation of integrated development plan and the annual budget
- Act as a link between a community and other stakeholders

## When asked about the roles of municipality board on public transport and management of market

#### He mentioned the following;

- Make bylaws on rate and other fees
- Revenue collections
- Traffic regulation and rule
- Construction of parking areas and passage

## When asked the criteria of town to be eligible for conferment of municipal status

## He mentioned the following;

- Availability of space for expansion
- Population of 50,000 and above as provided in urban areas and cities act.
- Capacity to generate own source revenue
