(STATEMENT SOUGHT FROM THE CHAIR COMMITTEE ON SPECIAL PROGRAMMES)

Mr. Speaker sir, I beg to request a statement from the chair committee on Special programme regarding the recent draught situation in the County. Mr Speaker sir, the Rising temperatures caused by climate change is making already dry regions at risk, increasing intensity and the shorter cycles between droughts is amplifying the vulnerability of the communities and their ability to cope.

Due to the prolonged drought, farmers have been unable to get any substantive crop production for quite sometimes and pastoralist communities have lost their livestock. The underperformance of the long rains made The situation in the ASALs continue to deteriorate.

These circumstances negatively affected the quality of life for both human and the livestock which resulted a serious impact on health, agriculture, livestock, energy and the environment

The chair should look into and consider the following:

- 1) Has the department done drought assessment survey? if yes provide the Report
- 2) What mechanisms has the department put in place to support the affected population in Sankuri ward and other parts of the County in terms of provision of food and non-food items?
