AN ACT of the County Assembly of Garissa to authorize allocation of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2024, and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Garissa, as follows—

Short title

1. This Act may be cited as the Garissa County Appropriation Act, 2023.

Appropriation of KSh. 10,357,146,448 out of the County Revenue Fund for the service of the year ending 30th June, 2024

2. The County Treasury may allocate the sum of Kenya Shillings Ten Billion, Three Hundred and Fifty-Seven Million, One Hundred and Forty-Six Thousand, Four Hundred and Forty-Eight only, out of the County Revenue Fund and apply it towards the supply granted for the service of the year ending on the 30th June, 2024 and that sum shall be deemed to have been appropriated as from 1st July, 2023.

Appropriation in Aid

3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule.

4. The supply granted for the services of the year ending on the 30th June, 2024, in respect of Votes R307-01, R307-02, R307-03, R307-04, R307-05, R307-06, R307-07, R307-08, R307-09, R307-10, R307-11, R307-12, D307-01, D307-02, D307-03, D307-04, D307-05, D307-06, D307-07, D307-08 D307-09, D307-10, D307-11, and D307-12 in accordance with the Garissa County Appropriation Act, 2023.
