#### **RESPONSE TO THE STATEMENT SOUGHT FROM THE CHAIR COMMITTEE ON ROADS AND TRANSPORT**

**Mr. speaker sir,**

Pursuant to standing order no 41(2) c, I wish to request for a statement from the chairperson of the sectoral committee on Roads, Transport and Public Works, regarding the status of Roads in the County.

**Mr. Speaker Sir,** Vision 2030, the Kenya government blueprint acknowledges the need for a functional transport sector as a component of the economic pillar, whose effort is expected to tackle such challenges as reduction of poverty by half and the achievement of newly

industrialized country status by 2030. According to the ministry of Transport and infrastructure policy paper (2012), roads are one of the models of transport of people and goods and are used to interconnect other models as well as provide access to basic social services.

**Mr Speaker Sir**, roads are key enablers for economic, social and political development as provided in Kenya's blueprint. Therefore, roads must be managed in a prudent and effective manner.

**Mr Speaker Sir**, considering that the majority of the roads within the county are in dilapidated conditions and that residents of Garissa County find difficult to access or transport their products from one station to another during the rainy season.

**Hon speaker**, the chairperson should enquire into and report on

1. Status of entire Garissa county roads after the heavy downpour of rains?
2. What mechanisms has the department put in place to open up access roads in the entire county?
3. Are there any plans to embark on heavy grading of all the feeder roads within the county for the purpose of easing accessibility?
4. Has the county done classification and naming of all feeder roads and if it was done could this be made available.
5. Has the county done a review of the conditions of all the county roads for purposes of establishing priority?
