### (STATEMENT SOUGHT FROM THE CHAIR COMMITTEE ON EDUCATION, ICT AND INFORMATION SERVICES)

#### Hon. Speaker,

Pursuant to standing Order 41 (2) (c), I wish to request for a statement from the chairperson of the Sectoral Committee of Education, ICT and Information Services regarding Library services in the County.

**Hon. Speaker**, pursuant to paragraph 2 (4) (f) of Part Two of the fourth Schedule to the Constitution provides the functions and power of the county government on Cultural activities, public entertainment and public amenities, including libraries.

**Hon. Speaker,** library services act as a resource center and vital to the growth and development of the county. Most sub counties lack this essential service therefore, this house urges the County Executive Committee Member for Education to expand these services and seek to digitalize those services.

**Hon. Speaker,** the situation of the county library is devastating; the building is seriously dilapidated and most of the furniture's and equipment are out of use. Therefore, the county government must do something to restore the condition of the library.

Hon. Speaker, there are revenue generated from the Safaricom and Airtel mast located within the library premises, before devolved to the County Government that revenue was being paid to national government. Since the library function is devolved, this house also seeks information regarding those revenues.

**Hon. Speaker**, in the statement the Chairperson should inquire into and report on;

- 1. What plans do the county government have to expand library services in the county?
- 2. Whether the county has plans to digitalize library services and also create more space for learning?
- 3. The plans by the department to increase packaging and re-packaging of information in respect to provision of extension services.
- 4. What are the plans by the department to renovate the County Library since the building is seriously dilapidated?
- 5. Whether the county is receiving revenue generated from Safaricom and airtel mast located within the library compound? and if yes, how much and when it started?
