# (STATEMENT SOUGHT FROM THE CHAIR COMMITTEE ON FINANCE, BUDGET AND APPROPRIATION)

**Mr. Speaker Sir**, The constitution of Kenya 2010 provides the basis for monitoring and evaluation as an important part of operationalizing Government activities to ensure that transparency, integrity, and accountability principles are embraced in resource allocation and management at devolved levels of Government. The scope of Monitoring and Evaluation is derived from the provisions related to planning under articles 10, 56, 174, 185, 201,203 and 225, 226,227 of the Kenya Constitution 2010.

**Mr. Speaker Sir**, With the advent of devolution, the County Integrated Monitoring and Evaluation System (CIMES) Guidelines were developed to assist County Governments design M&E systems for tracking implementation of County Integrated Development Plans (CIDP) and other interventions.

**Mr. Speaker Sir**, The County Monitoring and Evaluation Policy articulates: the government's commitment to accountability for development results; defines mechanisms for measuring the efficiency and effectiveness of public policies, programmes and project.

Monitoring and evaluation helps to determine exactly when a programme is on track and when changes may be needed. It also forms the basis for modification of interventions and assessing the quality of activities. It also ensures prudent use of resources

**Mr. Speaker Sir**, the Chair for Finance, Budget and Appropriation should inquire and report on;

- 1. The status of Monitoring and evaluation in the county?
- 2. Whether the county has directorate of M&E, If yes, its establishment and if M&Es are present in all departments.
- 3. Whether the county government has a Monitoring and Evaluation Policy in place and if Garissa has adopted County Integrated Monitoring and Evaluation System (CIMES), If No, when is Garissa County developing a Monitoring and Evaluation Policy to guide its operations and the timelines
- 4. What plans the county Government is putting in place to cascade the operationalization of the unit (M&E) with respect to the projects and all other undertakings of the County Departments?
- 5. Does the county government appropriate budget for M&E and how much annually?
- 6. How does the M&E unit link the other department and stakeholders such as NGOs, other Government institutions like NDMA, Kenya Red cross and KNBS?
- 7. If the County has an indicator handbook that is costed? If yes, attach a copy of the previous ADP with the indicator handbook for oversight?
