Hon. Speaker, Pursuant to standing Order 41 (2) (c), I wish to request for a statement from the Chairperson of the Sectoral Committee on Roads, Transport and Public Works regarding the road contract that was recently undertaken.

Hon. Speaker, paragraph 5 of the Fourth schedule to the Constitution 2010 provide for the functions and powers of the County Government on county transport including county roads, street lighting, public road, transport, traffic and parking. And also, County public works and services, including storm water management systems in built-up areas; and water and sanitation services have been devolved to the County Governments.

Hon. Speaker, most roads in county are affected by the recent heavy rainfalls and floods.

Hon. Speaker, in the statement the Chairperson should inquire into and report on;

- 1. How many roads were paved in the county after the recent rains? (attach road network data)
- 2. Provide the list of entities awarded those works
- 3. Was the tendering process transparent, kindly provide the necessary proof on the same.
- 4. Indicate the companies awarded and their respective amount per contract?
- 5. State whether tendering process was open and provide date of advertisement and a proof of the same?
- 6. Whether the tender was restricted or not?
- 7. What is the completion status of the roads projects and attach details on the same?
