Hon Speaker Sir, I beg to move the following Motion:

That, aware that ,article 43 (1) (f) of the constitution provides that every person has the right to education, which includes the right to Early Childhood Education.

Further aware that Education services specifically pre-primary education, village polytechnics, homecraft centres and childcare facilities have been devolved to the County Governments pursuant to paragraph 2 of Part Two of the fourth Schedule to the Constitution;

Appreciating that, Early Childhood education Act No 3 of 2021, part III (18) also mandates the County Government to register all ECDE centres in the County; where the County Education Board is satisfied that an education centre that is provisionally registered meets the

criteria for registration as an education centre, it shall grant full registration to the centre and issue to the centre, a certificate of registration.

Cognizant of the fact that, there are many unregistered early childhood education centres in the county

Deeply concerned that, That the attainment of education services is still a challenge in the county.

Now therefore, this Assembly urges the County Executive Committee Members (CECM) for Education, ICT and Information Services to;

1. Register all unregistered ECDE centres in the county in order to make them eligible for County Government support.
2. Develop standard and modernized ECDE centres with the enhanced ECDE curriculum
