Hon Speaker,

Pursuant to Standing Order 47(1)(c), I wish to request for a statement from the Chairperson for the Sectoral Committee on Lands, Housing and Urban Planning regarding the Roadside businesses in Garissa Municipality.

Hon Speaker, there are challenges associated with roadside businesses such as traffic congestion or zoning violations and environmental concerns. there are ways to address these concerns through thoughtful planning and collaboration with local authorities, business owners and community stakeholders.

Hon speaker, the chairperson should enquire into and report on;

1. The business operating on the roadsides are they registered?

2. Does the county government collect revenue from the roadside businesses? Have they been allocated the space they are operating their business?

3. If they were allocated those spaces to operate from who allocated to them?

4. What measures are being implemented to manage and reduce road congestion caused by businesses operating along major roads?

5. What steps are being taken to mitigate environmental hazards and pollution caused by roadside businesses?

6. Is there a plan to relocate certain types of businesses to reduce their impact on urban traffic and the environment?

7. What improvements are being made to public transportation and infrastructure to alleviate the pressure from roadside businesses?

8. Are there plans to develop dedicated commercial zones away from residential areas and major traffic routes?
