(STATEMENT SOUGHT FROM THE CHAIR COMMITTEE ON WATER AND IRRIGATION SERVICES)

Hon.Speaker, Pursuant to standing Order 47 (1) (c), I wish to request a statement from the Chairperson of the Sectoral Committee on Water and Irrigation Services regarding the services provided by GARUWASCO

Hon.Speaker, the right to water and sanitation is well defined under Article 43 of the Constitution of Kenya. Every person in Kenya has the right to clean and safe water in adequate quantities and the right to reasonable standards of sanitation.

Hon, Speaker, Water that is easily accessible and safe is essential for maintaining public health **and** better management of water resources, sanitation, and delivery can therefore significantly contribute to improved livelihoods and hence improved quality of life.

Hon.Speaker, currently, 32 percent of the Kenyan population still struggles to get their hands on dependable sources of safe drinking water. Sustainable Development Goals (SDGs) target addresses the achievement of universal and equitable access to safe and affordable drinking water for all by 2030.

On this note, the goal underscores the need for and importance of prioritizing efforts that aims at promoting universal access to safe drinking water to all.

Hon.Speaker, section 23. (1) of the Garissa County Water Management Act,2016, states that the County Executive Member may, establish rural water and sewerage services company. This entity is meant to help rural areas get sufficient and save supply of water.

Hon.Speaker, Further Section 58 (1) of the said Act states that, County Executive Member, shall monitor boreholes. all borehole drilling activities in the County to ensure compliance with the relevant licenses and applicable laws.

Hon, Speaker, in light of the above, the efforts made towards this by GARUWASCO is not realized by the residents of the County while even partnering with other agencies such as STAWI especially in the rural set ups, in the statement the chair should inquire and report on:

- 1) What is the Company doing in regards to maintenance of Rural boreholes?
- 2) The number of water projects undertaken by the entity and the distribution per ward?
- 3) The interventions so far done by STAWI, the areas of operation and the criteria used to settle?
