### Hon Speaker, I beg to give notice of the following motion

That, aware that, article 43 (1) of the constitution provides that every person has the right to the highest attainable standards of health, which includes the right to health care services, including reproductive healthcare.

**Further aware that,** Health Services including County Health facilities and primary health care have been devolved to the County Governments pursuant to paragraph 2 of Part Two of the fourth Schedule of the Constitution.

**Noting That**, the population served by Afweine Dispensary has significantly increased, and the demand for a wider range of health services has grown beyond the current capacity of the dispensary. Afweine Dispensary is limited in its ability to provide comprehensive medical care, including emergency services, maternal health, and specialized outpatient services due to its

current status as a dispensary. These dispensary plays a vital role in providing essential healthcare services to the people of Afweine and the surrounding communities

Appreciating That, upgrading of Afweine Dispensary to a health centre would greatly enhance healthcare access and improve health outcomes by providing better infrastructure, equipment, staffing, and expanded medical services, including laboratory, pharmacy, maternity, and outpatient services. the upgrading of the dispensary would support the County Government's commitment to improving healthcare infrastructure, reducing the distance patients have to travel to access essential medical services, and enhancing the overall wellbeing of the community;

**Now therefore,** this Assembly urges the County Executive Committee Members (CECM) for Health to upgrade Afweine Dispensary to a health centre, including the allocation of necessary funds, the construction of additional facilities, procurement of equipment, and hiring of qualified personnel to ensure the provision of comprehensive healthcare services to the community.
