The Speaker Pannel's 4 Hon Khadija Idris Mohamed conveyed the following Petition-

**Regarding lack of water in Bulla College, Bulla hodan, Bulla manyatta, South b and parts of Bulla bashal, Bulla mzuri and Bulla masalani**

**Honorable Members,** Article 37 of the constitution of Kenya 2010 accords any person to present petition to the Assembly to consider any matter within its authority. Further standing

order 231(b) requires the speaker to report to the House any petition other than those presented by the member.

**Honorable Members,** I wish to report to the House that the office of the speaker has received a petition from the residents of Waberi Ward praying that the County Assembly to intervene and take swift action to resolve the water crisis at Bulla college, Bulla hodan, Bulla manyatta, South B and parts of Bulla bashal, Bulla mzuri and Bulla masalani.

**Honorable Members,** the petitioners emphasize that, Article 43(d) and (b) of the Constitution of Kenya 2010 explicitly recognizes that every person has the right to clean and safe water in adequate quantities and to a reasonable standards of sanitation.

Further the petitioners decry that, despite the existence of twin water tanks with a total capacity of 576,000 liters located within Garissa University in Waberi Ward, the residents have been without adequate water supply for over eight years that led to significant hardship for the community.

**Honorable Members,** the petitioners also confirm that they have made efforts to have the matter addressed by the relevant body and the same has failed to give a satisfactory response.

**Honorable Members,** having established that the matter raised in the petition is well within the authority of this House; and further that the matter raised in this petition is not pending before any court of law, constitutional or legal body. I hereby commit the petition to the Water and Irrigation Services Committee for consideration pursuant to the provision of standing order 233(1).

**Honorable Members,** the committee is required to consider the petition within sixty calendar days and report its findings to the House and to the petitioner in accordance with standing order 233(2).
