Hon. Speaker, Pursuant to Standing Order 47(1) (c), I wish to request for a statement from the Chairperson of the Sectoral Committee on Water and Irrigation Services regarding the lack of water in Shidle center Sankuri Ward.

Hon. Speaker, Article 191 of the Constitution of Kenya, 2010 outlines the functions and powers of the County Government, which include the provision of water services to our residents. It is essential that we uphold these devolved water functions while respecting constitutional rights.

Hon Speaker, Article 43(1)(d) of the Constitution guarantees the right to clean and safe water for every individual. It emphasizes that access to accessible and adequate water services is a fundamental right, and the State has a duty to ensure the provision of these services.

Hon speaker, Shidle center in Sankuri Ward is currently facing a complete lack of water supply. This situation poses serious challenges for the residents as they are unable to access clean and safe drinking water for their daily needs. The absence of water not only affects health but also impacts local agriculture and overall quality of life.

Hon Speaker, in the statement the Chairperson should inquire into and report on;

- i. Whether the department is aware about the lack of water in Shidle center Sankuri ward?
