Hon. Speaker, Pursuant to Standing Order 47(1)(c), I Wish to request a statement from the Chairperson of the Sectoral Committee on Health regarding the upgrading of Kasha Dispensary to a fully operational healthcare center.

Hon. Speaker, Kasha Dispensary plays a vital role in providing essential health services to the surrounding community. However, the growing population and the increasing demand for more comprehensive health services have placed significant pressure on the dispensary's capacity to serve effectively. Currently, the dispensary lacks adequate facilities, equipment, and personnel to cater to the expanding healthcare needs of the population, resulting in frequent referrals to distant health centers and hospitals.

Hon. Speaker,

Pursuant to Standing Order 47(1) (c), I hereby request a statement from the Chairperson of the Sectoral Committee on Education, ICT, Vocational Training and Library Services regarding Technical and Vocational Education and Training (TVET) Institutions in the County.

Hon. Speaker, Article 53 1 (b) of the Constitution of Kenya (2010) ensures that every child has the right to free and compulsory basic education. This includes a right to access quality secondary and post-secondary education, which can encompass TVET programs.

Hon Speaker, Article 55 of COK 2010 states that the government's responsibility to ensure the youth (defined as individuals between the ages of 15 and 35 years) are empowered through education and training. The State shall take measures to ensure that young people have access to relevant education, training and opportunities for employment and self-employment.

Hon speaker, TVET institutions play a crucial role in providing technical and vocational training to the youth, helping to equip them with the necessary skills for employment and entrepreneurship.
