2. (STATEMENT SOUGHT FROM THE CHAIR COMMITTEE ON EDUCATION, ICT AND VOCATIONAL TRAINING)

Hon. Speaker, Pursuant to Standing Order 47 (1)(c), I rise to request a statement from the Chairperson of the Sectoral Committee on Education, ICT and Vocational training regarding the inadequacy of teachers, equipment, and subordinate staff at Mikono Vocational Training Center.

Hon. Speaker, Mikono Vocational Training Center plays a critical role in equipping students with practical skills necessary for personal development and employment opportunities. However, the effectiveness of this institution is being hampered by significant challenges, notably the shortage of qualified teaching staff, essential equipment, and subordinate personnel to support day-to-day operations. These issues limit the institution's ability to deliver quality training and, ultimately, to meet the needs of the students and the community at large.

Hon. Speaker, in the statement, I request that the Chairperson inquire into and report on the following:

1. What steps has the Department taken to address the shortage of teachers at Mikono Vocational Training Center? Is there a recruitment plan in place to ensure adequate staffing levels to meet the demands of the various courses offered?

2. What is the current status of equipment necessary for effective training in various trades at the center? Are there any plans to procure, upgrade, or repair existing equipment to ensure students receive hands-on, practical training?

3. What measures is the Department taking to address the shortage of subordinate staff at the training center? Are there efforts to increase staffing for roles critical to maintaining a clean, organized, and efficient learning environment?

4. Does the Department have a comprehensive plan to ensure long-term support for Mikono Vocational Training Center, including sustainable staffing levels, ongoing equipment maintenance, and resource allocation?
