1. (STATEMENT SOUGHT FROM THE CHAIR COMMITTEE ON FINANCE, BUDGET AND APPROPRIATION)

Hon. Speaker, pursuant to standing order 47, (1)(c) I rise to seek a statement from the chair committee on Finance, Budget and Appropriation regarding the status of funding to Garissa County Public Service Board.

Hon. Speaker, the constitution of Kenya outlines the role and functions of the County Public Service Board (CPSB) in chapter 11 part 2, article 176. The County Public Service Board is a crucial body responsible for managing the county's public service.

Hon Speaker, The County Public Service Board (CPSB) is funded through the county government's budget. The CPSB, as part of the county government's administrative structure, receives its operational budget from the county treasury. This budget covers expenses like salaries, operational costs, and other necessary expenditures to fulfill its mandate. The total allocated budget for the Garissa county public service board is Ksh 70,743,617(recurrent-Ksh 55,743,617 development- Ksh 15,000,000)

Hon Speaker, the board is unable to undertake its operations due to constraints in funding

Hon Speaker, the chairperson should inquire into and report on;

1. Why the Executive has not remitted allocation to the autonomous entity?
2. Status of operational cost to the board including provision of transport and office emoluments?
3. The CEC to provide statement and reconciliation with bank statements on funding to the board?
4. The CECM to provide E-Statement from the Integrated Financial Management System (IFMIS)?
5. Clarification on whether the board has an operational bank account? If not, an explanation for the lack of such an account?
